Packing: Standard Carton for sea or air transport.</p> <p>3. Insurance (Just for FOB and CFR) Covering all risks for 110% of Invoice Value to be effected by the Buyer.</p> <p>4. Quality and Product Inspection: quality is subject to the samples provided by seller. The buyer should check the quality within 30 days after received the goods, the goods can be used only after the quality is approved.</p> <p>5. Quality /Quantity Discrepancy: In case of quantity discrepancy, claim must be filed by the Buyer within 7 days after the arrival of the goods at port of destination, while for the quality discrepancy, claim must be filed by the buyer within 30 days after arrival of the goods at port of destination. It's understood that the Seller shall not be liable for any discrepancy of the goods shipped due to which Insurance Company, Shipping Company, other Transportation Organization or Post Office.</p> <p>6. Delayed for 15 days, Seller have the right to resell the standard items of the order to third party and ask the buyer to afford the relative cost.</p> <p>8.
